Jane Radack moved to extend a contract to all teachers who met their self-evaluation standards as reported by TEC and to Joanne Brinkley. Anne Patterson seconded and the motion passed with Joanne Brinkley and René Lemons-Matney abstaining.

Heather Kelejian moved to extend [REDACTED] contract with the stipulation that she successfully complete her GIT. Michelle Frazier seconded and the motion passed with Joanne Brinkley and René Lemons-Matney abstaining.

Jane Radack moved to go into Executive Session. Michelle Frazier seconded and the motion passed. Executive Session began at 9:00pm.

Jane Radack moved to go out of Executive Session. Heather Kelejian seconded and the motion passed. Executive Session ended at 9:28pm.

Anne Patterson motioned to extend the contracts for the two administrative positions with a change of the contract under “evaluation” to read “Administrators will complete and submit, as specified by the board of directors, an evaluation” pending approval by an attorney. Jane Radack seconded. The motion passed with one opposed. Joanne Brinkley and René Lemons-Matney abstained.

The Executive Committee shall be charged with considering how to proceed with certain personnel issues brought before the board.

René Lemons-Matney motioned to adjourn. Joanne Brinkley second and the motion passed. The meeting adjourned at 9:55pm.
